ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Vel College of Education, No. 7/4, Jawahar Nagar, New Dharmapuram Road, Palani-624601, Dindigul District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for B.Ed Course on 12.01.2007.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for B.Ed course on 07.11.2007 with an annual intake of 100 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 25.08.2010 submitted for Rs.40,000/- towards permanent affiliation. A letter was issued to the institution on 93.09.2010 to clarify the purpose for which D.D of Rs.40,000/- submitted.

AND WHEREAS, the institution submitted its reply stating that the D.D of Rs.40,000/- was sent for the purpose of shifting of college from rented building to our own premises for the purpose of permanent affiliation. Documents required in connection with shifting of premises relating to land etc

AND WHEREAS, the committee considered the matter in its 197th meeting held on 13-14 October 2010 and decided to cause inspection. Inspection of the institution was fixed on 16-17 November 2010 but inspection of the institution could not be conducted as the institution vide its fax dt. 29.10.2010 requested to postpone the inspection date for another four months. Again inspection of the institution was refixed between 24th January 2011 and was intimated to the institution on 17.01.2011. Accordingly, inspection of the institution for shifting of premises was conducted on 08.02.2011.

AND WHEREAS, the SRC in its 201st meeting held on 22-23 February, 2011 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly, Show cause notice was issued to the institution on 05.04.2011. The institution had submitted its roply on 05.05.2011.

AND WHEREAS, the SRC in its 205th meeting held on 18-19 May, 2011 considered reply & found that the reply of the institution is not convincing and hence unsatisfactory and decided to <u>withdraw</u> the recognition for B.Ed. course. Accordingly, withdrawal order was issued to the institution on 27.07.2011.

AND WHEREAS, the institution preferred appeal to NCTE, Hqrs and the Appellate Authority vide order dt. 04.11.2011 has reversed the withdrawal order of SRC with a direction to causing reinspection of the new premises of the institution and for taking further decision thereafter. Accordingly, the appeal is accepted and the order of SRC dated 27.06.2011 is reversed.
